Level C:	Specialized \$100
	Authorizes work with respect to solar or satellite installations, swimming pools, and tennis courts.

	Authorizes work with respect to roofing, framing, fences, retaining walls, sprinkler irrigation, landscaping, mechanical, signs, etc., and single trades when not set forth for higher level licenses.
