  - 2) Products, completed operations: two million dollars (\$2,000,000.00).
  - 3) Personal and advertising injury: one million dollars (\$1,000,000.00).
  - 4) Each occurrence: one million dollars (\$1,000,000.00).

Proof of current Workers' Compensation and General Liability insurance coverage shall include the name of the business, name of the insurance company, policy number, effective and expiration dates, and a statement naming the City of Greenwood Village as the certificate holder. Proof of coverage may be sent by mail or email.

Note: Workers' Compensation coverage is required if the business has any employees. **The expiration of any insurance coverage and/or the application will render your license inactive.**
