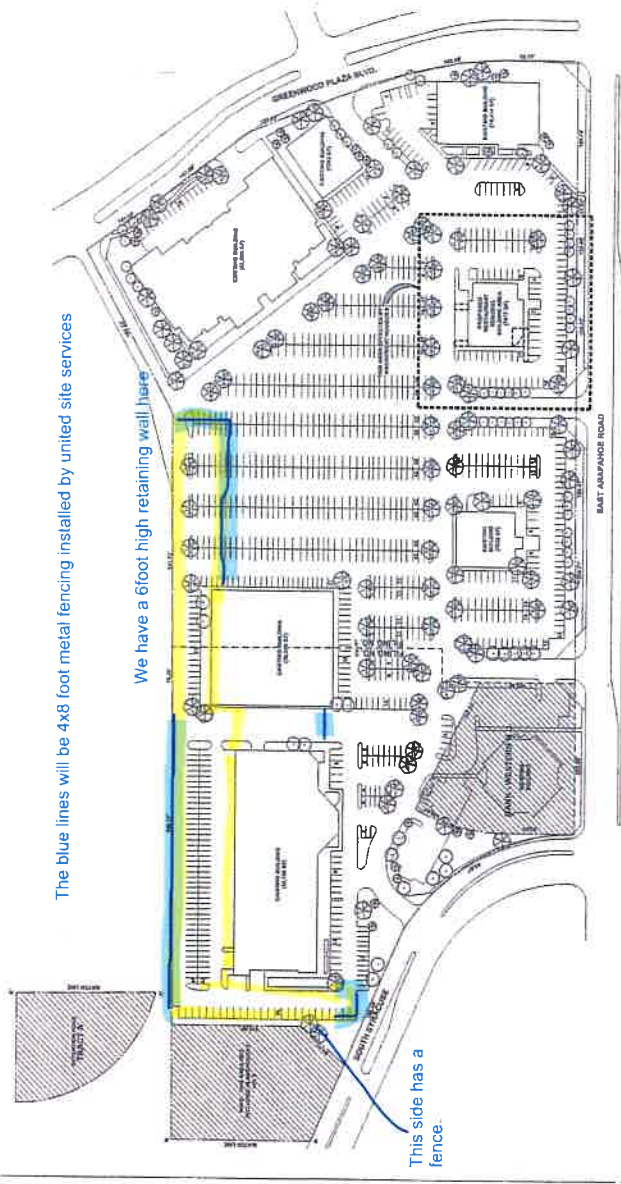

Boundary:

- 4 foot by 8 foot metal fencing will be used in combination with large retaining walls surrounding the entire space to be used.

Ingress & Egress:

- We will have 3 points of entry and exit for the event
- Each point of entry will have a hired security guard stationed at all times along with 2 employees.

Signage:

- We will have no alcoholic beverage beyond this point signs stationed at all 3 points of exit. We also will post them on all temporary fencing surrounding the space.

Responsible Service:

- We will have a booth set up for id check and wrist band control.
- Wrist bands will be secured to individuals who are 21 years or older. ID's will be checked by TIPS certified employees.
- All alcoholic beverages will be served by TIPS certified employees who have been trained to recognize intoxication.
- We will also have roaming security guards for the event to assist with crowd and alcohol control.
